The purpose of this acquisition is to procure a service agreement for DeltaVision Ultra Imaging System. The LMB is acquiring a 1-year service agreement to maintain this instrument so that the Government's Cancer Research Program continues without interruption. This full coverage service agreement includes all labor, travel, and parts with unlimited breakdown calls, and one scheduled Preventative Maintenance visit per year.

The National Cancer Institute plans to purchase an Equipment Maintenance Agreement . This is not a request for competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine is the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on Mar 18, 2021 ET. A determination by the Government not to compete this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered solely for the purpose of determining whether to conduct a competitive procurement.

**Sole Source Justification:**

The DeltaVision Ultra Live Cell Imaging System with air table and cabinet is the only live cell imaging system on the market specifically designed for deconvolution microscopy and the long exposures of live images. This very specialized system can only be serviced by the manufacturer's technicians.

A Web search was performed and an imaging core facility contacted. Dr. Tatiana Karpova in NCI, CCR, LRBGE confirmed that there are no other vendors that can service this type of instrument.

## **Statement of Work for DeltaVision Ultra Imaging System Service Agreement**

**Scope:** The Laboratory of Molecular Biology (LMB) has a DeltaVision Ultra Live Cell Imaging System with air table and cabinet, for observing live cells over time in vitro. This instrument is used by several investigators in LMB and requires precise adjustment and maintenance to be operational at all times.

**Preventative Maintenance:** Contractor shall perform one preventative maintenance visit during the agreement period. Service shall be performed by technically qualified trained personnel. Service will be available Monday through Friday, between the hours of 9 am and 5 pm. Technician will respond within 24 hours of a trouble call to schedule service.

**Emergency Service:** Emergency repair services shall be provided on an unlimited basis during the period of this agreement. Emergency service calls shall not replace the necessity for scheduled PMs.

**Replacement Parts:** This agreement covers the cost of engineer travel, all parts, and labor during the period of coverage. All service parts included are on a part-for-part exchange basis only. Parts shall be new or remanufactured to original equipment specifications.

**Service Exclusions:** The contractor shall not be responsible for any repairs necessitated by abuse, neglect, vandalism, fire or water. These repairs shall be done on a separate purchase order.

**Period of Performance:** The period of performance is March 22, 2021 through March 21, 2022.

The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its postacceptance rights-

(1) Within a reasonable period of time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(e) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence, such as acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

## FAR 52.204-24 Representation Regarding Certain Telecommunications and Video Surveillance Services or Equipment. Basic (Dec 2019)

### Prescription

As prescribed in 4.2105(a), the contracting officer shall insert the provision at 52.204-24, Representation Regarding Certain Telecommunications and Video Surveillance Services or Equipment—

(1) In all solicitations for contracts; and

(2) Under indefinite delivery contracts, in all notices of intent to place an order, or solicitations for an order ( e.g. , subpart 8.4 and 16.505).

### Full Text

#### Representation Regarding Certain Telecommunications and Video Surveillance Services or Equipment

The Offeror shall not complete the representation in this provision if the Offeror has represented that it “does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument” in the provision at 52.204-26, Covered Telecommunications Equipment or Services-Representation, or in paragraph (v) of the provision at 52.212-3, Offeror Representations and Certifications-Commercial Items.

(a) *Definitions.* As used in this provision—

“Covered telecommunications equipment or services”, “critical technology”, and “substantial or essential component” have the meanings provided in clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

(b) *Prohibition.* Section 889(a)(1)(A) of the John S. McCain National Defense Authorization Act for Fiscal Year 2019 (Pub. L. 115-232) prohibits the head of an executive agency on or after August 13, 2019, from procuring or obtaining, or extending or renewing a contract to procure or obtain, any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system. Contractors are not prohibited from providing—

(1) A service that connects to the facilities of a third-party, such as backhaul, roaming, or interconnection arrangements; or

(2) Telecommunications equipment that cannot route or redirect user data traffic or permit visibility into any user data or packets that such equipment transmits or otherwise handles.

(c) *Procedures.* The Offeror shall review the list of excluded parties in the System for Award Management (SAM) (<https://www.sam.gov>) for entities excluded from receiving federal awards for “covered telecommunications

telecommunications equipment or services", the Offeror shall provide the following information as part of the offer—

- (1) A description of all covered telecommunications equipment and services offered (include brand; model number, such as original equipment manufacturer (OEM) number, manufacturer part number, or wholesaler number; and item description, as applicable);
- (2) Explanation of the proposed use of covered telecommunications equipment and services and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b) of this provision;
- (3) For services, the entity providing the covered telecommunications services (include entity name, unique entity identifier, and Commercial and Government Entity (CAGE) code, if known); and
- (4) For equipment, the entity that produced the covered telecommunications equipment (include entity name, unique entity identifier, CAGE code, and whether the entity was the OEM or a distributor, if known).

(End of provision)

Subcontractor Flow Down Text

While the provision doesn't include an explicit flowdown requirement, it does require the offeror to certify that it will not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument.
